TERMS OF CONTRACT

The parent or guardian authorizes the student to take part in the program on the basis that the student meets the physical requirements specified by law for issuance of a motor vehicle operator's license. The student must be at least 14 years 8 months of age by the beginning of class (verification by birth certificate required).

The dates for this course are _____. JEVS, LLC d.b.a. J & J Driving Academy will provide a minimum of 24 hours of classroom instruction, 6 hours of Behind the Wheel (BTW) instruction, and 4 hours of observation time. Classroom instruction must be a minimum of 3 weeks in length. BTW instruction shall not begin until the student has received a minimum of 4 hours of classroom instruction. BTW instruction must be completed no later than 3 weeks after the classroom instruction has been completed. Students that successfully pass the course may be certified at this point. All classroom instruction will be held at Lincoln Park High School, 1701 Champaign, Lincoln Park, MI 48146. BTW instruction will start from the student's residence, or else the school where classroom instruction is held.

The total course fee of \$285.00 is payable in full, or installments. The first payment of at least \$100.00 is due at registration, with the remaining \$185 due the first day of class. We accept cash, check, debit/credit card or money order. There will be a \$25.00 charge for any lost or damaged textbooks. There will be a \$15.00 charge for not showing up for a behind the wheel driving instruction without a 24-hour notice. There will be a \$20.00 charge for all returned checks.

If account balance is not paid in full by the last day of class, there will be a late fee assessed of \$25.00 and student will not receive certificate until paid in full.

If 1 or 2 classes are missed for whatever reason, they must be made up in the next Segment 1 session. If more than 2 classes are missed, the entire course must be retaken in the next Segment 1 session, else all monies will be forfeited.

A class average of 70% must be obtained through class work and quizzes to pass this course. A score of 70% on the state test is required to be eligible for your Segment 1 permit.

J & J Driving Academy will conduct the BTW instruction in a dual controlled automobile, fully insured, covering each student enrolled in the program. J & J Driving Academy is available if additional classroom and BTW instruction is needed for students to complete the Michigan Department of State program for an additional fee. There will be a \$25 fee per make-up session.

REFUND POLICY

If a student is unable to begin the course, for any reason, they will be refunded all monies paid less a \$30.00 registration fee. If a student withdraws from a class after it has started they will be assessed a registration fee of \$30.00, plus a \$20.00 fee for every behind the wheel instruction, and a \$10 fee for every class attended. No refund will be processed until all materials and supplies are returned.
