For a student to take part in Segment 2, verification must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a level 1 license, which has been held for not less than 3 continuous months.

The total course fee of \$50.00 is due at registration. We accept cash or money order. There will be a \$25.00 charge for any lost or damaged textbooks. If a student has been absent, a make-up date will be held. There will be a \$25 charge per make-up date.
